Over the past 14 years, the Brown County Foundation has awarded over 100 grants to area projects. Grant amounts have ranged from \$50.00 to \$2,000.00. 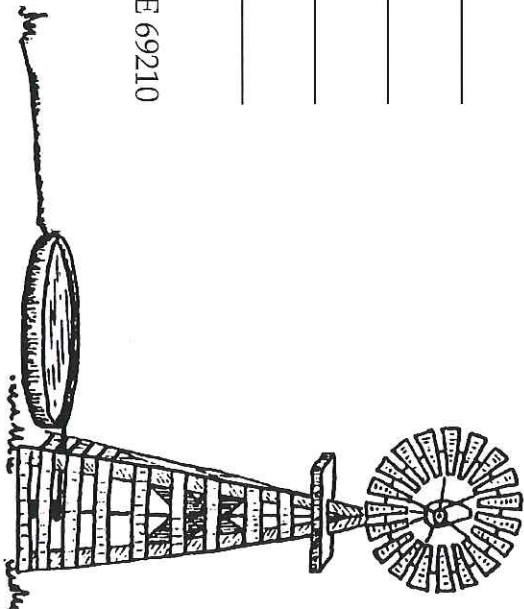
