BUILDING A STRONG FOUNDATION

For generations, residents of Plattsmouth have enjoyed a wonderful quality of life. To ensure that future generations of Plattsmouth continue to have that opportunity, the Plattsmouth Community Foundation Fund (PCFF) was established in the fall of 2000 with the objective to serve as a funding mechanism and a way for people to give back to the community. Each year, grants are awarded to projects and programs that have long-term positive impacts on our community. Grants have supported:

- Youth programs and childcare
- Entrepreneurship development and training
- Healthcare and safety
- Recreation and tourism
- Education and leadership development training
- Economic Development
- Historic Preservation

PCFF has given back over \$625,000 to the community since its inception.

The Nebraska Community Foundation completed an analysis of the inter-generational transfer of wealth likely to occur in Cass County over the next 50 years. This analysis has generated some dramatic estimates including:

- The peak period for transfers of wealth will occur in 2040, and will decline sharply for 20 subsequent years.
- This wealth transfer in Cass County currently exceeds \$96 million per year.
- If just 5% were gifted locally an endowment of \$24 million could be built. \$1.2 million would be available each and every year for community betterment.

The Plattsmouth Community Foundation Fund is an affiliated fund of the Nebraska Community Foundation. This helps keep our operation costs low to better serve our community.
