#### LOCAL ENDOWMENTS PROVIDE THE ABILITY TO DREAM BIG

For over twenty years, generous people who care about Valley County have been growing a hometown legacy through gifting to local endowment funds. These gifts not only last forever, they increase in size! In 2018, the VCCFF achieved a challenge grant of raising \$500,000 in unrestricted endowment funds with the promise of an additional \$250,000 in matching funds. This unrestricted endowment, the Vibrant Future Fund, and several other restricted endowments support high impact granting to numerous worthy causes such as education, youth engagement, leadership development, entrepreneurial endeavors, arts and cultural experiences, community infrastructure, and newcomer attraction. Annual payouts are also used as levering funds when we apply for external grant opportunities! Since 2011, over \$250,000 in community grants have been reinvested in Valley County. ### SYNOVATION VALLEY LEADERSHIP ACADEMY



The VCCFF is proud to grow human capacity through support for Synovation Valley Leadership Academy. In 2023, SVLA is celebrating 10 years of entrepreneurial and personal transformation programs which have positively impacted nearly 200 participants and numerous regional businesses from across Nebraska, as well as in other states.

SVLA is a world class, personal leadership development program that provides participants with abundance mindset tools, entrepreneurial masterminds, and business and culture transformation opportunities. SVLA's continued work to enhance leadership capacity and encourage business development is essential for the future of greater Nebraska. The foundation of SVLA is a coaching methodology which brings forth each person's unique knowledge, skills, perceptions and competencies to empower individuals to tap into their most brilliant selves.

Since the program's inception, the VCCFF has contributed over \$60,000 in grant funds to support local leadership growth, including the purchase of podcasting equipment and operation costs. This equipment allows SVLA to provide an in-person experience to zoom participants and reach a broader audience, including participants from Kansas, South Dakota, Minnesota, and Texas.

# EMBRACING CREATIVITY AS THE STORED HONEY IN OUR COMMUNITY

The VCCFF is pleased to inspire and support a thriving local arts culture through sponsoring diverse creative experiences and engaging in arts asset mapping. Over the past eight years, the Fund has collaborated with The Golden Husk Theatre to host a Missoula Children's Theatre residency, with an annual grant of \$3,750. This residency is an extraordinary opportunity for 64 area youth to share their artistic gifts and discover their passions, while building meaningful relationships and leadership skills as they work with the MCT professional directors and cast members. The experience engages youth and their families from over twelve communities on an annual basis!

Other annual arts experiences supported by the VCCFF include the Nebraska Grown Art Festival and The Fabulous Accordion Festival. Both of these events showcase the talents of local artists, honor our rich heritage, and attract patrons from across the state to Valley County. From 2020 to the present, the VCCFF has strengthened the local arts culture with over \$30,000 in grants from endowment funds.

The VCCFF believes embracing and engaging individuals' creativity positively touches every aspect of community development from solving problems to creating opportunities. Through the practice of arts asset mapping, which involves interviewing community members to learn about their innate gifts, passions, skills, and dreams for their community, the VCCFF has developed an inventory of local creatives who work together to enhance community vitality.
