

## Bridging the Learning Gap

Shickley Community Foundation Fund is part of a nearly \$1.2 million statewide effort to bridge the learning gap in the face of COVID-19. Through a two-round funding opportunity requiring a 1:1 local match, Shickley Community Foundation Fund applied and received grants in both rounds totaling a \$39,884 investment in Shickley Public School.

In round one, Shickley Community Foundation Fund received and matched \$8,200 to purchase Chromebooks. In round two, the SCFF received and matched another \$11,742 to purchase iPads and sound amplification systems for the hearing impaired. As a result of this opportunity, all K-12 students are now equipped with a device allowing them to both learn remotely in the midst of a global pandemic and enhance learning through technology in more normal times.

The Bridging the Learning Gap funding opportunity was made available exclusively to affiliated funds of Nebraska Community Foundation (NCF). The initiative was capitalized by an anonymous NCF donor and the Alice DeVoe Donor-Advised Fund, an affiliated fund of Nebraska Community Foundation.

Grants were approved and allocated by a committee of six volunteer NCF affiliated fund leaders who have educational expertise, including teachers, administrators and school board members. All applications received funding. Importantly, learning gap needs were identified locally by school leadership, as were proposed solutions.

"We are deeply proud of the way the NCF network and affiliated funds like Shickley Community Foundation Fund came together to meet this need," said Jeff Yost, president and CEO of Nebraska Community Foundation. "We are so grateful to the visionary donors who are supporting this important work and to the local leaders and educators who are rolling up their sleeves to ensure our kids receive the educational experiences they deserve, even in the midst of a global crisis."



### Keeping Our Community Connected

The COVID-19 pandemic has changed many long-held assumptions in just a few months. One of these assumptions is that we can easily and frequently visit loved ones and friends who are patients or residents of hospitals, assisted living or nursing home facilities. For much of 2020, patients and residents of many of these facilities could no longer have visitors. Once again, Shickley Community Foundation Fund took advantage of a funding opportunity available through its affiliation with Nebraska Community Foundation to assist and prevent community members from feeling isolated and alone.

The Alice DeVoe Donor-Advised Fund, an affiliated fund of Nebraska Community Foundation, and another anonymous donor offered matching grants to NCF affiliated funds like Shickley Community Foundation Fund to connect those in healthcare facilities with family and friends, including electronic devices and complementary equipment. Shickley Community Foundation Fund applied for a \$1,000 grant and contributed another \$1,100 to purchase iPads for the Fillmore County Hospital keeping the members of our community connected to the people they love in an unprecedented year.

### Unrestricted Opportunity

Think of all the ways our community has evolved over the past 20 years. Change is happening at lightning speed in ways we never could have dreamed. Children born today will occupy jobs we can't even imagine. There is no way to predict what the world will look like in another 20 years, so how can Nebraska communities like Shickley invest wisely for the future?

Shickley Community Foundation Fund's answer to this question is simple: build an unrestricted endowment for our hometown. Flexible, locally controlled opportunity capital that can be used to foment positive change—the kind of change that may otherwise not occur. The kind of change that cannot be anticipated today.

Similar to a community savings account, unrestricted endowments are an important tool to keep Shickley growing, thriving, and improving for future generations. While a portion of the income earned by an unrestricted endowment is granted annually to fund projects and programs to benefit the community, the principal remains intact and grows every year. Forever.

Because endowments are permanent, and the investments are managed for growth, the annual amount available for granting continues to grow as well. The real value of an unrestricted endowment is that, in 20 years, community members in Shickley will be able to unleash its energy in a future far different from today, without restriction and without



the burden of being able to predict what the future holds.

Having a locally controlled, unrestricted endowment will allow you, and the generation of leaders who come after you, to have the discretionary dollars to make the most of opportunities continuous change will bring. A gift to Shickley's unrestricted endowment is an investment in the future and truly the gift that keeps on giving.
