LEIGH LEGACY FUND

is an affiliated fund of Nebraska Community Foundation, a statewide nonprofit organization working to unleash abundant local assets, inspire charitable giving, and connect ambitious people. NCF works with 246 affiliated funds benefitting 272 hometowns in 83 Nebraska counties. All members of the NCF network are working toward one shared vision – to build stronger communities and a Greater Nebraska.

Our affiliation with NCF allows LLF to receive tax-deductible contributions and complex gifts like real estate and agricultural commodities. NCF also handles all gift receipting, accounting, legal work, investments, and audit and tax filing to ensure we are fully compliant with IRS rules.

But our affiliation with NCF is about much more than fiduciary management. NCF's support and services help communities across Nebraska go further faster—from training for volunteers on fundraising, community

visioning, asset mapping, and leadership development, to furnishing a full-service marketing department, robust web presence and capabilities, the industry's foremost software products, and much more. Affiliating with NCF also opens doors to opportunities to connect with statewide partners, major funders, donors, and a community of professional advisors in every corner of the state. Most importantly, our NCF affiliation connects our volunteers to a network of ambitious Nebraskans—peers across the state who are also working to better their places, too. ■

LEIGH LEGACY FUND is focused on building a permanent unrestricted endowment, an important tool to keep our hometown growing, thriving, and improving for future generations. It creates a steady stream of revenue for community needs today and those that arise in the years to come.

Funds that go into LLF's unrestricted endowment are invested and continue to grow. The principal is never touched, and the investment earnings increase over time. Any gift made to the LLF endowment is a “forever” gift.

As the endowment grows, so will the investment earnings. A portion of these earnings will serve as a “payout” for future grants the Fund will be able to give to area groups to support projects and programs that enhance quality of life in Leigh and the surrounding area. The principal—and your gift—remains intact and grows forever.

What are your hopes and dreams for the future of Leigh? With an unrestricted endowment, those dreams are within our reach! Together we'll create a community our children and our children's children are proud to call home. ■

A NOTE FROM THE LEIGH LEGACY FUND

HELLO FRIENDS of Leigh living both near and far!

Beginning in July 2019, members of the Leigh Area Foundation voted to affiliate with Nebraska Community Foundation (NCF), a statewide nonprofit organization providing shared ideas and resources to nearly 250 communities across the state. With our official affiliation in January 2020 came a name change, and we are now the Leigh Legacy Fund. The addition of the word “Legacy” reflects our desire to make a lasting impact on the community of Leigh.

After joining NCF, we expanded our fund advisory committee (FAC) as well as our vision for the future, and we have never looked back! As an affiliated fund of NCF, we receive support in finance, planned giving, community development, education, and communications. Importantly, all grantmaking decisions are made at the local level by FAC members.

The 13 members of our FAC are deeply committed to the future of this community. The main goal of Leigh Legacy Fund (LLF) is to increase charitable giving among those who love this community as much as we do and to make grants that enrich the quality of life for present and future generations, preserve our heritage, and nurture our sense of community.

We will do this primarily by establishing an unrestricted endowment. Funds that go into LLF's unrestricted endowment are invested, the principal is never touched, and the investment earnings increase over time. In other words, any gift made to LLF's unrestricted endowment is a “forever” gift. A portion of the invested earnings serve as “payout” to be granted to programs and projects that benefit the community of Leigh and surrounding area every year.

Anyone who donates to LLF's unrestricted endowment has not put forth any specific guidelines on how the money is used beyond benefitting the people and community of Leigh. Donors to the unrestricted endowment trust the LLF Advisory Committee to decide how the money is spent (with welcome input from the community!) Unrestricted gifts provide ultimate flexibility for the future as we cannot anticipate community needs 10 years from now, 50 years from now, and beyond.

Members of the Legacy Fund are so proud of the exciting things happening in our community. The support shown by so many people in our short time as a fund has been truly inspiring. So many people for so many years have worked tirelessly to make Leigh the great place it is. By working to build our unrestricted endowment, we want to do our part to capitalize on the strengths and assets Leigh already has and continue to build the community for future generations!

LLF RECEIVES GIFT FROM BILL AND THERESA EGGERS FAMILY TRUST

EARLIER THIS YEAR, the Leigh Legacy Fund received the wonderful news that it would be the recipient of a \$250,000 gift from the estate of William (Bill) and Theresa Eggers.

Bill, the son of Alvin and Olga (Renner) Eggers, was a 1968 graduate of Leigh High School. After graduating, Bill served as a radio technician in the United States Marine Corps from 1969–1974. He married Theresa Bowman of Louisville, Kentucky in 1970. Following his discharge from the Marines, Bill worked for the Metropolitan Sewer District in Louisville as a clerk, union president, equipment operator, and wastewater treatment operator, level 4. Theresa worked as a computer programmer for Blue Cross & Blue Shield insurance company. After retiring, Bill and Theresa moved to Leigh and operated Bill's Bar from 1999–2012. The bar was a "Family Tradition" loved by many. Bill was also a member of the Leigh Volunteer Fire Department for 13 years, Civil Defense Coordinator for 10 years, and a member of Sucha Post 302 of the American Legion, Leigh, Nebraska.

Bill passed away in 2017 and Theresa in 2020. Above all, they had a love of family and community, and their gift will impact the community of Leigh for generations to come. The Leigh Legacy Fund wishes to express its utmost gratitude to Bill, Theresa, and their family for their generosity. A gift of this magnitude in the first year of the Legacy Fund's inception is truly inspiring and humbling.

All proceeds were used to fund the Leigh Alumni Association scholarships. It was a great way for Legacy members to be of service to the community and increase our visibility.

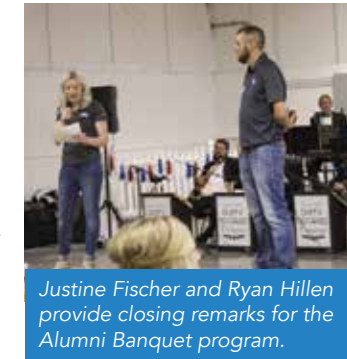
The day's festivities started at 3 p.m. with tours of the new high school given by members of the Leigh Youth Advisory Committee.

In late March 2020, LLF organized a “Bear Hunt” for the Leigh community. LLF Chair Justine Fischer read the story *We’re Going on a Bear Hunt* by Michael Rosen, and it was posted on the Legacy Fund Facebook page the night of the event.

The fund then asked residents to place stuffed teddy bears in their windows or on their property and encouraged families to cruise through town searching for them. Nearly 100 homes and businesses participated in the display and over 150 bears and other animals were counted overall.

This was a bittersweet process, as many dedicated individuals and organizations

put so much time and work went into preserving the museum through the years. Although there are no immediate plans for the structure itself, the Legacy Fund and Village Board agreed that steps needed to be taken to preserve the living history of Leigh before it is too late! ■

COMMUNITY COLLABORATORS

LEIGH LEGACY FUND would like to give special thanks to our special collaborative partners, the Leigh Community Club and Leigh Youth Advisory Committee.

The Legacy Fund works closely with both groups. The Community Club is an amazing community asset with dedicated volunteers who sponsor community-building programs such as Santa, Easter Bunny, Trunk or Treat, Movie in the Outfield, and Winterfest. The Community Club fully supports LLF’s mission to build a permanent unrestricted endowment and has not held its annual membership drive for the past two years. Instead, they ask you to support the Legacy Fund with future donations. The Community Club will continue to use the money in their existing account until it is exhausted. From that point on, they will be funded solely by LLF.

The Leigh Youth Advisory Committee (founded in 2015) is a group of students in grades 10–12 who care deeply about the community of Leigh and about community in general. The group considers itself the youth component of LLF. YAC’s mission is to help students foster a sense of pride in their community and learn more about civic responsibility and leadership. The YAC group for the upcoming 2021–22 year is the biggest ever at 31!

These students are required to observe numerous community meetings throughout the year, including Legacy Fund meetings. They also take part in various community service projects each year such as painting street lines and other various paint projects, as well as organizing the biannual Leigh Christmas Festival and Tour of Homes. All profits the students raise through the Christmas Festival and working concession stands throughout the school year are donated back to the community with the students deciding fully how to spend the money they raise. The group’s most recent projects include a new scoreboard for the ball field in 2019 and a wallpaper mural celebrating the history of Leigh in the main entrance of the new high school that was installed this spring. ■

Our legacy is the impact that lasts long after our lives have ended. How do you want to help shape the future? What charitable work must continue? Leigh Legacy Fund and NCF can help you put your assets to work with tax-efficient charitable strategies while also supporting the causes most important to you. Some popular ways to give include:

■ GIFTS IN A WILL OR TRUST

You can make a charitable gift by designating a percentage or a specific dollar amount of your estate. This type of gift is flexible and revocable.

■ BENEFICIARY DESIGNATIONS

Many financial accounts, CDs, mutual funds, annuities, and life insurance policies allow you to make a charitable gift using beneficiary designations.

■ RETIREMENT PLANS

You can make a charitable gift using the beneficiary designation of your IRA, 401(k) or other retirement plan. This type of gift avoids estate and income

taxation on the assets accumulated tax-free during your lifetime.

■ GIFTS OF LIFE INSURANCE

Life insurance offers flexible ways to make a charitable gift of an existing policy or new policy.

■ GIFTS THAT PROVIDE INCOME

You can make a gift now, get immediate tax benefits, ensure that you or a loved one receives income payments for life, and make a future charitable gift.

■ REAL ESTATE

When you make a charitable gift of the real estate, you pay no capital gains tax when it is sold by the charity.

■ GRAIN OR LIVESTOCK

Allow a farmer or rancher to avoid claiming the sale price of the commodity as income and deduct the cost of production as a business expense.
