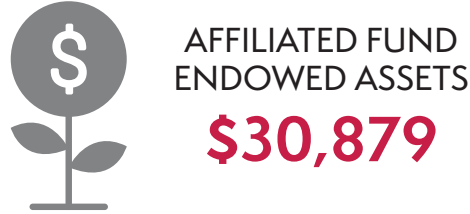
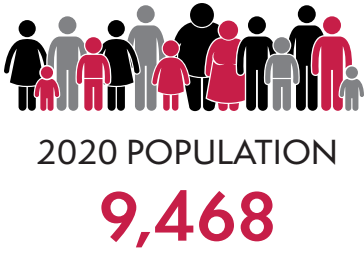
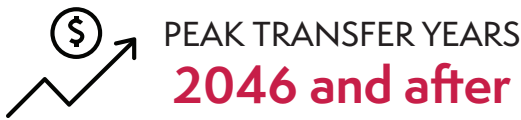


# THE TRANSFER OF WEALTH IN CHEYENNE COUNTY

Over the next 10 years in Nebraska, more than **\$100 billion** will transfer from one generation to the next. In 50 years, that number exceeds **\$950 billion**. This phenomenon has come to be known as the intergenerational transfer of wealth. There is always a transfer from generation to generation, as parents pass away and leave their estate to their children. But if the heirs no longer live where they grew up, that wealth may leave as well.

## WHAT WE KNOW

1. Nebraska has incredible wealth and ALL Nebraska communities have wealth to give.
2. The wealth is transferring NOW and we must act with urgency.
3. Our communities need these assets and many are already successfully putting them to work.
4. When we leave some of our wealth to the places where it was made and accumulated, we can ensure a more prosperous future for our Nebraska hometowns.

## THE OPPORTUNITY IS MASSIVE

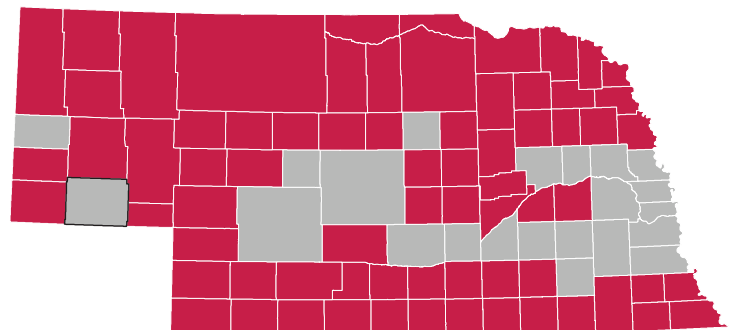
Over the next 10 years in Cheyenne County, \$564 million will transfer from one generation to the next. In 50 years, that number exceeds \$5.3 billion. The wealth may be held in real estate, securities, retirement accounts, and other assets. Some will go to taxes. Most will go to heirs. Due

to outmigration, many of those heirs no longer live where the wealth was built and may no longer feel connected to those places. Once wealth leaves our communities, the opportunity for give-back becomes more and more unlikely.

## THE TIME IS NOW

Many Nebraska counties are approaching or are already in the midst of their peak transfer years. In other words, there is real urgency to act now. The opportunity will never be greater.
