Over the next 10 years in Nebraska, more than \$100 billion will transfer from one generation to the next. In 50 years, that number exceeds \$950 billion. This phenomenon has come to be known as the intergenerational transfer of wealth. - **4.** When we leave some of our wealth to the places where it was made and accumulated, we can ensure a more prosperous future for our Nebraska hometowns.


THE OPPORTUNITY IS MASSIVE

Due to outmigration, many of those heirs no longer live where the wealth was built and may no longer feel connected to those places.
