But if the heirs no longer live where they grew up, that wealth may leave as well.

THE OPPORTUNITY IS MASSIVE



to outmigration, many of those heirs no longer live where the wealth was built and may no longer feel connected to those places. Once wealth leaves our communities, the opportunity for give-back becomes more and more unlikely.
